No. 96/392/88-IIR-Mines/5338

(In the matter of II renewal of Mining Lease for Concession No. 13 of 10-02-1950, belonging to Late Shri Xec Abdul Kadar).

1. And whereas, Late Shri Xec Abdul Kadar was a holder of mining concession for Iron and Manganese Ore granted under T.C. No. 13 dated 10-02-1950 covering an area of 69.00 ha. land situated in village Tudou of Sanguem taluka.

2. And whereas, consequent upon the enactment of the Goa, Daman and Diu Mining Concessions (Abolition & Declaration as Mining Leases) Act, 1987, the above mining concession appearing at Sr. No. 44 of Schedule I to the said Act, 1987 stood abolished and declared as Mining Lease under the Mines and Minerals (Development and Regulation) Act, 1957.

3. And whereas, Shri Shaik Kassim claiming to be legal heir of Late Shri Xec Abdul Kadar vide application dated 21-11-1988 applied for renewal of deemed mining lease for further period.

4. And whereas, by an Order No. 96/392//88-Mines/1747 dated 11-12-2001 the said application was rejected by the Secretary (Mines), Government of Goa and had also declared the mining lease as lapsed under Section 4 A (4) of the Act 57 read with Rule 28 of Mineral Concession Rules, 1960.

5. And whereas, against the said order Shri Shaik Kassim filed a revision application before the Central Government on dated 04-03-2002. Whereas Revision Authority dismiss the Revision application vide its final Order No. 1(i) on dated 31-01-2007.

6. And whereas, in the mean time Shri Shaik Abdul Rahim (hereinafter referred to as the "applicant") claiming to be legal heir of Late Shri Shaik Kassim, vide application dated 23-10-2006 has applied for renewal of the above mining lease over the same area which was rejected earlier.

7. And whereas, there is no subsisting right in favour of Shri Shaik Abdul Rahim in the said area in question. Whereas the application dated 23-10-2006 is therefore liable to be rejected.

8. And whereas, by a notice bearing No. 96/392/88/IIR-Mines/558 dated 10-06-2009 the applicant was called upon to attend the personal hearing on 18-06-2006, and to show cause as to

why the application dated 23-10-2006 should not be rejected, in term of Rule 26(1) of MCR, 1960.

9. And whereas, it is seen that the notice was issued to applicant on 10-06-2009 which was returned by the postal authorities with remark "unclaimed" and it appears that the said notice is deemed to be valid notice as per available record. Hence the renewal application is submitted on 23-10-2006, is liable to be rejected as the applicant unclaimed the notice for personal hearing.

10. And whereas, it is seen that the application dated 21-11-1988 filed for 1st renewal period has been rejected by Secretary (Mines) Government of Goa and this order has not been set aside, as per the available records. In the absence of any order setting aside the order of rejection, the applicant has no subsisting right in respect of the aforesaid lease and consequently the question of considering the application for renewal of a non-existent mining lease afresh does not arise. Hence the application submitted on 23-10-2006, is liable to be rejected.

11. And whereas it may be recalled, on 23-05-1987, the Goa, Daman & Diu Mining Concessions (Abolition & Declaration as Mining Leases) Act, 1987, Central Act No. 16 of 1987 was enacted. By virtue of Section 4 of this Act, 1987, the mining concession contained in Schedule I & Schedule II appended to the Act were deemed to have been abolished, and were deemed to be mining leases granted under the Mines & Minerals (Development & Regulation) Act, 1957. This Act, 1987 was challenged before the Hon'ble High Court of Bombay at Panaji, in W.P. No. 177/90. The Hon'ble High Court in its order dated 20-06-1997 uphold the enactment of 1987, Act. Aggrieved by the above, Special Leave Appeal (Civil) No. 23827/97 was filed, (M/s. Shantilal K. Das & Bros. & another (Petitioners) v/s GOI & other Respondent) before the Hon'ble Supreme Court of India.

The Hon'ble Supreme Court in its order dated 02-03-1998 has directed that during the pendency of the appeals, the appellants are permitted to carry on mining operation an mining business in the mining areas for which renewal applications have been made on the condition that the appellant shall pay to the respondents from the date of commencement of the impugned Act all the amount of dead rent, royalty as now stipulated by the respondents under the impugned Act without prejudice and other protest. The appellant will also comply with all other conditions. As regards the period from 1961 till the coming into force of the impugned Act, it will be open to the

respondents to rake proceedings for assessment of the amounts payable by the appellants but no recovery shall be made without further order from the Court.

12. In the light of above I, Shri R. K. Verma, Principal Secretary (Mines), Government of Goa in exercise of the power conferred upon me vide Notification No. 5/80/89-Mines dated 17-11-1989 hereby reject the application dated 23-10-2006 for renewal of Mining Lease for further period as the applicant has no subsisting right in respect of aforesaid lease and consequently the question of considering the application for renewal of non-existing Mining Lease does not arise.
