- (vii) He is permitted to associate himself with the charitable/educational activities being carried out by him prior to his joining the GSPCB. There is no objection for him being a member of various statutory/non-statutory Committees/Boards of the Central/State Governments.

3. Further, Shri Jose Manuel Noronha is entitled for deduction for leave salary and pension contribution calculated on the basis of last pay drawn in the pay scale which he was drawing, prior to him joining the GSPCB. His services rendered as Chairman (GSPCB) shall be counted
