Inquiry Report

On the basis of media reports, which appeared in the local newspaper "Herald" under captions (1) "It's a mad scene at IPHB", 2) "IPHB lacks infrastructure to help calm tense nerves" and 3) "Plights of patients at IPHB" unending even after cure" dated 25th June, 2012, 26th June, 2012 and 29th June, 2012 respectively, this Commission issued notices to the Chief Secretary, Government of Goa, 2) Secretary (Health), Government of Goa and 3) the Dean, Goa Medical College, Bambolim (hereinafter referred to as Respondents Nos. 1, 2 and 3 respectively).

2. In pursuance to the notices, the Respondent No. 3 filed a detailed reply alongwith several documents. The Respondent Nos. 1 and 2 have generally adopted the reply filed by the Respondent No. 3. The Respondent No. 3 stated that there are no violations of human rights on the part of IPHB and whatever lapses which are visible outwardly are purely of administrative in nature. It is further stated that the news appearing in the daily "Herald" is highly exaggerated and therefore no cognizance of the same should be taken.

3. As far as the media report under caption "It's a mad scene at IPHB" dated 25th June, 2012 is concerned, the Respondent No. 3 has admitted that several posts are lying vacant. However, the Respondent No. 3 has explained the circumstances under which the posts are lying vacant. The Respondent No. 3 has submitted information of all the vacant posts at IPHB (Annexure-A) indicating that steps are being taken by the IPHB for filling up the vacancies. Annexure-A shall form a part of this Inquiry Report.

4. With regard to the media report under caption "IPHB lacks infrastructure to help calm tense nerves" dated 26th June, 2012, the Respondent No. 3 has stated that there are two

occupational therapy centres, one for male patients and the other for female patients. Each of these centres has a recreational therapist who organizes exercises and prayers to the patients. Entertainment programmes are also organized periodically. The patients play games like carom cards, snake and ladder, lodes skipping, etc. which help to calm the patients nerves. There are also O.T. technicians, handicraft instructor, tailors. etc who teach various skills like tailoring shell work, handicraft work out of coconut shells and husk, etc. In the case of Male O.T. there is a painter and carpenter who train patients in painting and carpentry. All these activities go a long way to calm tensed nerves of the patients. It is further stated that a Day Care Centre shall be constructed which will have various facilities to do exercises, yoga meditation, indoor games, mini library, etc. It is stated that the proposal for administrative approval and financial sanction has been sent to the Government vide letter No. 59/12/2005-EST/3254 dated 07-12-2012.

5. As far as the media report under the caption "Plights of patients at IPHB unending even after cure" dated 29-06-2012 is concerned, the Respondent No. 3 has stated that there are 65 patients who are free from mental illness but they cannot be discharged due to rejection by their families and wherever possible such patients are sent home alongwith attendants in Government vehicles from January, 2012 onwards. It is further stated that the Psychiatric Social Worker has been entrusted with the work of placements of these patients in different institutes meant for destitutes in Goa.

6. We have gone through the media reports. We have also perused the replies filed by the Respondents and documents enclosed alongwith the reply of Respondent No. 3. We have also heard the Ld. Adv. Shri Arun Talaulikar for the Respondents.

7. By Notification No. 2/10/80-PHD dated 80-12-1980, published in the Official Gazette (Extraordinary) by the then Government of Goa, Daman and Diu, the Government decided that the then existing Medical Hospital situated at Altinho which was functioning under the Directorate of Health Services and the Department of Psychiatry of the Goa Medical College and which were catering the needs of mental patients to amalgamate into single Government Department in order to providing optimal medical and mental health services. Accordingly, Professor and Head of Department of Psychiatry and Human

Behaviour, Goa Medical College was appointed to act as Director of the Institute of Psychiatry and Human Behaviour until a regular post of Director was created.

8. This Commission also paid a visit to the Institute of Psychiatry and Human Behaviour, Bambolim on 13-05-2013 to ascertain the factual position prevailing at IPHB, Bambolim. The Commission visited various Wards of the Institute namely 1) Open Female Ward, 2) Electro Conversion Therapy Wards (Both Male and Female), 3) Mentally III Patients Ward (Female), 4) Mentally III Patients Ward (Male) and 5) Ward of Male and Female. We found that all the above mentioned wards were clean. The clothes worn by the inmates were also found to be clean. Some of the patients were found busy in recreational activities. We also visited the kitchen and found that it was clean and tidy. The toilets were also found to be clean. May be, because we had visited the Institute by giving prior notice, conscious efforts had been made and the wards had been tidied up. We would fervently hope that the authorities concerned would make sincere efforts to maintain cleanliness throughout the year. The Commission also noticed that IPHB is in possession of huge area including structures located in it. There are scattered trees mostly non-fruit bearing in the said land. There is a vast scope for planting various types of trees to make the Institute environmental friendly. There is also scope to use the land around the Institute for recreational activities for the inmates of the Institute.

9. The documents produced and the information furnished of all the vacant posts (Annexure-A) clearly indicate that the Respondents are making efforts to fill up the vacant posts. However, it is apparent that there is inordinate delay on the part of the State Government to fill up the vacancies particularly in respect of the post of Director. The reply of Respondents Nos. 1 and 2 clearly indicates that the post of Director has not been created so far and the proposal is under examination of ARD since 15-02-2013. It is unfortunate that the very vital post of the Director of the Institute has not been created even though more than three decades have passed ever since the establishment of the Institute of Psychiatry and Human Behaviour. This lethargic attitude of the State Government cannot be lightly brushed aside. It is high time that the State Government takes a serious view of such lapses and make a concerted effort for filling up the post of the Director and also the other posts which are lying vacant for a

long period of time. In our opinion, the posts cannot be kept vacant for a long period of time which is bound to have an adverse effect on the overall functioning of the Institute.

10. It is also noticed by the Commission that the Institute also lacks basic infrastructure although efforts are being made by the State Government to provide necessary basic infrastructure. This process also is required expedited to promote the welfare of the inmates of the Institute.

11. The Commission therefore makes the following recommendations.

1. The State Government shall expedite the process of filling up of the post of Director of IPHB without any further delay.
2. All other posts which are lying vacant shall also be filled up as expeditiously as possible.
3. All the basic infrastructure should be made available to the Institute to promote the welfare of the inmates.
4. A Day Care Centre may be established on priority basis having facilities for physical exercises, yoga, meditation, indoor games, library, etc.
5. The patients who are fully recovered should not be kept at IPHB alongwith other inmates but they should be shifted immediately to proper place in safe environment.
6. The large area of land in possession of IPHB should be utilized for recreational activities of the inmates of the Institute.
7. Various types of trees may be planted to make the Institute environmental friendly.
8. It is expected that sincere efforts should be made to maintain cleanliness throughout the year.

A copy of this Inquiry Report shall be forwarded to the State of Goa through the Chief Secretary in terms of Section 18 (e) of the Protection of Human Rights Act, 1993.

Action taken or proposed to be taken by the State Government shall be communicated to this Commission on 13-12-2013.

AWARD

(Passed on 16th day of July, 2013)

In exercise of the powers conferred by clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) (for short the Act), the Government of Goa by order dated 24-11-2000 bearing number IRM/CON/SG/(36)/98/5877 has referred the following dispute for adjudication by this Tribunal.

"(1) Whether the action of the management of M/s. Four Seasons Resort, The Leela Beach, in terminating the services of Miss Fatima D'Costa, Senior Nurse with effect from 18-4-1998, is legal and justified?

(2) If not, to what relief the Workperson is entitled?"

2 On receipt of the reference, a case was registered under No. IT/89/00 and registered A. D. notice were issued to the parties. Upon receipt of the notice, Party I filed the claim statement at Exb. 4, Party II filed the written statement at Exb. 5 and thereafter Party I filed the rejoinder at Exb. 6.

3. In the claim statement, it is in short the case of Party I that she joined The Leela Beach five star hotel as a trainee nurse. Her services were confirmed on 14-12-1992 and since 1995 she started working for the said hotel as a senior nurse. That Party II terminated her services w.e.f. 18-4-98 without holding proper and fair enquiry or without affording any fair opportunity of being heard. Party I thus raised the Industrial dispute however settlement could not arrive at. It is stated that Party II has not complied with Section 25 of the Act so also Section 25 (b) of the Act. It is stated that Party I was at all times the employee of M/s. Leela Beach (now known as M/s. Leela Palace) and not of M/s. Four Seasons Resort at any time and thus M/s. Four Seasons Resort had no authority/locus standi to terminate the services of Party I and hence such termination w.e.f. 18-4-98 under letter dated 17-4-98 is without any authority, illegal and bad in law. It is stated that services of Party I have been terminated in violation of clauses 5(a), (b), (d) and (f) of the Fifth Schedule of the Act.

4. In their defence Party II has stated that the reference is not maintainable; that Party I was not qualified to work as a nurse and since Party I was not ready to work in any other department, her services had to be terminated. It is also the case of Party II that Party I is gainfully employed and hence she is not entitled to any reliefs.

5. In the rejoinder Party I has denied the contentions raised by Party II in the written statement.

6. In view of the averments of the respective parties, following issues were framed on 15-11-07/13-8-09.

1. Whether the reference is bad in law?
2. Does the Party I prove that termination of her services w.e.f. 18-4-1998 by the Party II is illegal and unjustified?
3. Does Party II prove that the Party I is gainfully employed?
4. To what relief the Party I is entitled?
5. What Award?

7. In support of her case Party I, Miss Fatima D'Costa examined herself as witness No. 1 and Shri Antonio D' Costa was examined as witness No. 2. Party II examined its Manager (H.R.D.) Shri Vijay Kumar Ainapurkar as witness No. 1 and Shri Adrian D' Souza as witness No. 2.

8. In the course of further proceedings both the parties settled the matter amicably amongst themselves and filed the terms at Exb. 44, reading as under:

1. It is agreed between the parties that the Management of M/s. Four Seasons Resorts (The Leela Palace Goa), Mobor, Cavelossim shall pay a sum of Rs. 1,00,000 (Rupees one lakh only) to Party I/Fatima D'Costa, by Cheque No. 000103 dated 27-06-2013 drawn on Oriental Bank of Commerce, payable at par which shall include all the claims of Fatima D'Costa arising out of the present reference and her Employment and termination. The above amount shall include all her claims including any claim of earned wages, bonus, leave encashment, gratuity etc. or any other claim which can be computed in terms of money.

2. It is agreed that Fatima D' Costa shall accept the said amount mentioned the clause (1) in full and final settlement of all her claims arising out

of present reference and in complete satisfaction of her employment and termination, including any claim of earned wages, bonus, leave encashment, gratuity etc. or any other claim which can be computed in terms of money and further confirm that she shall have no claim of whatsoever nature against the company including any claim of reinstatement or re-employment.

3. The above terms are signed by both the parties as well as their respective advocates.

9. I have gone through the terms of the settlement entered into between the parties towards amicable settlement of the dispute. I accept the said terms and pass the following:

ORDER

1. The reference stands disposed off by consent award in view of the consent terms filed by the parties, at Exb. 44.

2. No order as to costs.
