Government is pleased to introduce a modified scheme viz. "Government Intervention for Control of Price Rise" in the State of Goa taking into account the factor and conditions of supply, procurement and

sale of essential food commodities and agricultural produce, through its implementing agencies viz., the Goa State Horticulture Corporation Ltd. Accordingly the scheme is proposed to be implemented with effect from 10th February, 2014.

1. *Short title and commencement.*— (a) This scheme shall be called as "Government Intervention for Control of Price Rise Scheme, 2014".

(b) It shall come into effect on the 10th day of February, 2014 and remain in force till it is withdrawn.

2. *Objectives of the scheme.*— (a) The Government intends to subsidize the supply of certain essential food commodities and agricultural/horticultural produce, as listed, to the residents of Goa in a bid to ease off the inflationary pressures which the market exerts on the Goan consumers due to insufficiency of locally grown agricultural produce and the over-dependence on agricultural products imported from outside the State.

(b) The scheme envisages providing subsidy at the hands of the Goan consumer who is a resident of Goa, directly, at the time of purchase/procurement through the outlets managed by the Goa State Horticultural Corporation Ltd., for the purchases of agricultural/horticultural produce. Further, the scheme envisages providing subsidized quantity of certain food commodities, as per the select list, to Goan consumers at the specified outlets which could be availed on production of ration cards by the consumer.

3. *Essential commodities and agricultural/horticultural produce eligible for subsidy.*—

(a) The following commodities shall be supplied to Goan residents on production of ration cards at the specified outlets of Goa State Horticultural Corporation Ltd., as well as at other outlets of Societies or Federation (Agencies) as notified by the Government from time to time as per the details below:

Sr. No.	Commodity	Maximum quantity
1.	Tur dal	2 kgs. per month per card.
2.	White peas (Vatana)	2 kgs. per month per card.
3.	Green grams (Moong)	2 kgs. per month per card.
4.	Wheat flour (Atta)	4 kgs. per month per card.
5.	Sugar	2 kgs. per month per card.

(b) The following agricultural/horticultural produce shall be produced by Goa State Horticultural Corporation Ltd., and supplied at subsidized rates based on the price of procurement of individual items and sold to the Goan consumers at the Goa State Horticultural Corporation Ltd., outlets. Maximum quantity of subsidized vegetables

per person per day shall be limited to 2 kgs. of each item. The details of the agriculture produce is produced below:

4. *Supply and distribution of commodities and agricultural/horticultural produce.*— (a) It

will be the responsibility of the Goa State Horticultural Corporation Ltd., to procure, supply and monitor distribution and sale of the food commodities and agricultural/horticultural produce at its various outlets as specified by them.

(b) Goa State Horticultural Corporation Ltd., shall be entitled to claim reimbursement of the subsidy portion of the essential commodities as well as the agricultural/horticultural produce as per the conditions provided in the scheme.

(c) Financial assistance shall be provided for the mobile outlets of the Goa State Horticultural Corporation Ltd., based on the claims on daily basis and the places visited by the mobile outlet.

5. *Financial assistance under the scheme.*—

(a) The Goa State Horticultural Corporation Ltd., shall be eligible to claim an amount equivalent to 25% of the total procurement value of the vegetables contained in list at clause 3(b) above. In respect of the commodities listed in clause 3(a) above, Goa State Horticultural Corporation Ltd., shall be eligible to claim a maximum margin of 5% on the total procurement value. Besides this, there shall be no other cost paid to the Corporation and they shall not be entitled to any costs

pertaining to overheads, taxes, levies, duties paid or payable by them to their suppliers, vendors, transportation agencies or any other agencies other than those specified in the scheme.

(b) The Goa State Horticultural Corporation Ltd., shall be eligible for financial assistance not exceeding Rs. 3,000/- per day for maximum 25 days in a month, for the mobile vans generally not exceeding 20 numbers. (Total No. of claim shall not exceed 500 trip days per month).

(c) The claims shall be settled on monthly basis on production of the certified copy of the purchases vouchers and formats annexed at I to V. The suppliers' statistics/sales statistics shall be maintained by the Goa State Horticultural Corporation Ltd. In case of mobile outlets, the Goa State Horticultural Corporation Ltd., shall invariably provide the sales statistics as well as deployment/distribution schedule.

(d) The claims put forth by the Goa State Horticultural Corporation Ltd., shall be settled as per the Budgetary provisions made for this scheme by the Directorate of Agriculture, which shall not exceed Rs. 20 crores in case of agricultural produce and commodities detailed at clause 3(a) and (b) above and Rs. 1.8 crores in case of mobile vans.

6. *Monitoring and implementation of the scheme.*— The scheme shall be monitored on monthly basis by the Directorate of Agriculture and shall be implemented through the Goa State Horticultural Corporation Ltd., and such other agencies to be notified by the Government from time to time. For the purpose of monitoring, the Director of Agriculture shall constitute a Cell under his chairmanship comprising Director of Civil Supplies & Consumer Affairs, or his representative, Director of Accounts, through his representative posted in the Directorate of Agriculture (Accounts Officer/Asst. Accounts Officer) and Dy. Director Agriculture in the Directorate of Agriculture.

7. *Interpretation.*— Issues, if any, arising with regards to interpretation of any clause,

word(s), expression(s) or the entire scheme, the decision in this respect shall vest with the Government.

8. *Redress of grievances and disputes.*— Grievances or disputes, if any, arising out of the implementation of the scheme, shall be submitted to and decided by the Minister for Agriculture and the decision taken in this respect shall be final and binding on all concerned.

9. *Powers to Relax.*— The Government shall, with prior consultation with the Finance Department, relax any or all the conditions specified above to meet the objectives of the scheme.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Savings.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
