No. 3604E dated 9-12-2013 issued by the Ministry of Environment and Forests, Government of India, New Delhi and published in the Government of India (Official Gazette), part II-section 3-sub-section (ii) dated 9-12-2013 and further published in the Official Gazette of Government of Goa in Series II No. 07 dated 15-5-2014.

In pursuance of clause (10) of the Notification dated 9-12-2013 read above, it is hereby notified that the sitting fees, site inspection fees and Travelling Allowance (T.A.) for the Chairperson and non-official Members of the Goa State Expert Appraisal Committee (Goa-SEAC) and Goa State Environment Impact Assessment Authority (Goa-SEIAA) shall be Rs. 2,000/- per member per sitting and Rs. 1,000/- per member per site inspection and Rs. 1,000/- per member as Travelling Allowance per day. The expenditure shall be debited to the account maintained by the Goa State Pollution Control Board (GSPCB) for the purpose, to which appropriate Grant-in-Aid shall be provided in pursuance to the clause (9) of the above read Order dated 9-12-2013.

Read: Government Notification No. 1/16/76-PER (Pt.III) dated 29-9-2014, published in the Official Gazette, Series I No. 28 dated 9-10-2014.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897), the Governor of Goa hereby amends the Government of Goa, Department of Information and Publicity, Group 'B', Non-Ministerial, Non-Gazetted post, Recruitment Rules, 2014, published vide Notification No. 1/16/76-PER (Pt.III) dated 29-9-2014, in the Official Gazette, Series I No. 28, dated 9-10-2014, (hereinafter called as the "said Recruitment Rules"), as follows, namely:—

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa is hereby pleased to make the following amendment to the Recruitment Rules for Group 'C' and 'D' posts in various Departments under the Government of Goa, as follows:—

In the Schedule annexed to the Recruitment Rules for various Group 'C' and 'D' posts under the Government of Goa, the existing age limit in the column prescribed for direct recruitment shall be enhanced by two years.

The relaxation in age limit provided to Government servants and other categories of personnel, wherever applicable, shall be in addition to the above increase in age limit of two years.

This Notification shall come into force from the date of its publication in the Official Gazette and shall remain in force for a period of one year from the date of its commencement.

Amendment to "The Scheme to Grant Monthly Financial Assistance to the Persons engaged in Traditional Occupation/ Businesses including Motorcycle Pilots".

Whereas vide Notification No. 82-6-07-08-SDB/Part-II dated 20-12-2012 published in the Official Gazette, Series I No. 23 dated 5-9-2013, the Government of Goa framed the scheme, viz. "The Scheme to Grant Monthly Financial Assistance to the Persons engaged in Traditional Occupation/Businesses including Motorcycle Pilots".

An whereas the Government has decided to amend the said scheme.

Now therefore, the Government of Goa hereby amends the said scheme as follows:

In objective of the scheme after para two, the below mentioned sentence will be added. "However an amount of Rs. 2,000/- (Two thousand only) p. m. shall be provided by the Government to the eligible Motorcycle Pilots".
