3/1/WS/2015-16/D.Agr./323

The following scheme approved by the Government of Goa is published herewith for the general information of the public.

1. *Short title & commencement.*— The scheme shall be called “One time assistance to farmers for removal of weeds/shrubs/bushes, aquatic weeds by hiring power driven machinery/equipments/manually”.

It shall come into force with immediate effect and shall remain in force till it is withdrawn or amended by the Government of Goa.

Now in order to alleviate the burden of such farmers, following scheme is designed “Assistance to clear weeds, bushes and shrubs to bring fallow lands under re-cultivation”.

2. *Objectives.*— (1) To bring fallow land under cultivation by removal of weeds, shrubs, bushes, etc.

(2) To bring more area under cultivation.

(3) To support farmers for cultivation of agricultural/horticultural Crop by providing assistance on hire charges of machinery/equipment.

3. *Eligibility criteria.*— (I) Individual farmers involved in cultivation of various types of agricultural/horticultural Crops.

(II) Farmer should be registered under Krishi Card Programme of the Directorate of Agriculture.

4. *Pattern of assistance.*— One time assistance of 50% of the expenditure incurred towards hire charges of machinery/equipment

including labour wages for removal of weeds/shrubs/bushes etc. will be provided limited to Rs. 15,000 per hectare or 50% of the actual expenditure whichever is less.

5. *Documents required.*— (I) Duly filled application form as specified.

(II) Copy of Krishi Card.

(III) Affidavit on Rs. 50/- stamp paper.

6. *Guidelines & Procedures.*— (I) Interested farmer shall apply to the Zonal Agricultural Officer (Z.A.O.) in whose jurisdiction the plot/field is located.

(II) He/she shall mention details of area to be cleared and type of machinery intended to be used.

(III) The concerned Z.A.O. will inspect/field and accord administrative approval if the proposal is found feasible.

(IV) Upon receipt of administrative approval, the farmer shall get the clearing work executed by hiring machinery/equipment from any private/public sector agency including labour and intimate the Z.A.O. regarding completion of the work and submit relevant payment vouchers/invoices.

(V) The cleared area should be used exclusively for cultivation of agricultural/horticultural crop.

(VI) The subsidy will be released only after verification and certification by Z.A.O. regarding satisfactory plantation of the Agricultural/Horticultural crop in cleaned/cleared area.

(VII) The farmer shall submit an affidavit on stamp paper of value as specified from time to time stating that he/she would exclusively utilise the concerned field/plot to cultivate agricultural/horticultural crop and continue to do so for six years or more.

7. *Relaxation.*— The Government shall be empowered to relax any or all clauses or conditions of the scheme in genuine cases. However release of financial assistance in such case will be considered only with approval of Finance (Exp.) Department.

8. *Interpretation.*— If any question arises regarding interpretation of any clause or word or expression of the scheme, the decision shall lie with the Government, which shall be final and binding on all concerned.

9. *Redressal of Grievances and Disputes.*— Grievances if any, arising out of the implementation of this scheme, shall be heard and decided by the Minister for Agriculture and the decision of the Minister of Agriculture in this regard shall be final and binding on all concerned.

*Sub.:* “Lease of Platform for drying fish at Fisheries Complex, Colva”.

The Government of Goa hereby introduces the new scheme namely “Lease of Platform for drying fish at Fisheries Complex, Colva” to traditional fishermen at nominal rate.

1. *Short title and commencement.*— (1) This scheme may be called as “Platform for drying fish at Fisheries Complex, Colva to Traditional Fishermen/Traditional Fish Drier”.

(2) It shall come into force from the date of its notification in the Official Gazette.

2. *Introduction.*— Fishing is one of the prime industry and fish drying is also most important activity performed in the State. A considerable number of traditional fishermen/fish driers are doing this activity for their livelihood. It is also observed that such type of activity of

drying fish in Goa is done in Fisheries Complex, Colva of Directorate of Fisheries since 1990. The Fisheries Department had constructed 30 fish drying platforms at Fisheries Complex, Colva in the year 1990 and the same were leased to the fishermen for many years.

Over the past few years these fishermen have been facing hardship in getting raw materials due to increase in number of fish meal plant in neighbouring States who are directly buying the raw material from jetties. Thus, these fishermen cannot perform their activity smoothly affecting their livelihood and also making it difficult for quoting higher amount for the drying platforms. Therefore, in order to sustain this traditional activity it is felt necessary to give these 30 fish drying platforms at a nominal rate to these fish driers who have been drying fish on these platforms for more than 10 years.

3. *Objectives.*— The main objective of the scheme is to provide the platform to traditional fish driers at a nominal rate of Rs. 100/- per platform/year for drying fish to sustain their livelihood and to keep alive the traditional activities of drying fish in the Fisheries Complex, Colva.

4. *Scope.*— The fish drying platform shall be given to the traditional fishermen/fisherwomen who have been drying the fish at the complex for more than 10 years.

5. *Beneficiary/Eligibility.*— Conditions to lease fish drying platform are as follows:—

(1) Fishermen/Fisherwomen should be local resident and born in Goa.

(2) Fishermen/Fisherwomen shall have annual income less than Rs. 1.5 lakh and possess Income Certificate issued by respective Village Panchayat/Mamlatdar.

(3) The Fishermen/Fisherwomen shall be traditional fishermen doing this activity at the complex for more than 10 years.

(4) The Fishermen availing for the scheme shall not be the defaulter of the Department of Fisheries.

6. *Terms and Conditions.*— (1) Platform shall be given to the beneficiary for the term of 3 years.

(2) The beneficiary shall execute agreement after allotment of platform.

(3) The beneficiary shall use the platform only for drying fish and not for other activities.

(4) The platform shall be given to traditional fish driers at a nominal rate of Rs. 100/- per platform/year.

(5) Each platform is having an area of 100 sq. mts. The beneficiary shall maintain cleanliness and hygiene of fish drying platform.

(6) The beneficiary shall permit the Government official or their duly authorised representative to inspect the fish drying platform.

(7) Any damage to any platform due to natural calamity shall be informed immediately.

(8) The beneficiary shall avail minimum of 3 fish dry platform for the period of 3 years. The same shall be restricted based on the number of applications received by Department from fish driers.

(9) Only one applicant from one family will be eligible for availing the benefit of the scheme.

(10) The beneficiary shall maintain general cleanliness and hygiene in the Fisheries Complex.

7. *Procedure for application.*— The application in prescribe form for the allotment of drying platform will be available at Sub Office, Fisheries Complex, Colva/Head Office and will be received at the Sub Office, Fisheries Complex, Colva. Application complete in all respect be forwarded to the Head Office. The application shall be submitted to the office by the month of June and July.

8. *Allotment Procedure.*— (1) There are 30 fish drying platforms at Fisheries Complex, Colva.

(2) The application form of applicant found eligible shall be granted three platforms.

(3) Allotment of drying platform will depend on the applications received to the Department on seniority basis.

(4) The platform will be allotted after due approval of the Government.

Whereas certain draft rules, so as to further amend the Goa, Daman and Diu Fisheries Rules, 1981, were published as required by sub-section (6) of section 6 of the Indian Fisheries Act, 1897 (Central Act 4 of 1897) in the Official Gazette, Series I No. 16, dated 17-7-2014 vide Notification No. DF/ENF/RENEWAL FEES/2014-15 dated 9-7-2014 of the Department of Fisheries, Government of Goa, inviting objections and suggestions from all persons likely to be affected thereby before the expiry of thirty days from the date of publication of the said Notification in the Official Gazette.

And whereas, the said Official Gazette was made available to the public on 17-7-2014;

And whereas, no objections and or suggestions have been received from the public on the said draft rules by the Government.

Now, therefore in exercise of the powers conferred by section 6 of the Indian Fisheries Act, 1897 (Central Act 4 of 1897), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa, Daman and Diu Fisheries Rules, 1981, namely:-

1. *Short title and commencement.*— (1) These rules may be called the Goa Fisheries (Amendment) Rules, 2015.

(2) They shall come into force w.e.f. 1st September, 2014.

2. *Substitution of Schedule.*— In the Goa, Daman and Diu Fisheries Rules, 1981, for Schedules I and II, the following shall be substituted, namely:—

Government of Goa is pleased to make the following scheme and publish the same for the general information of the public, which shall come into force from the date of publication in the Official Gazette.

Name of the scheme: "State Award For Physical Education Teachers"

**The objectives behind the State Award for P. E Teachers**

➤ To motivate the PE Teachers to accept the challenge of achieving excellence in the field of Physical Education and Sports, by training the school students in various Games and Sports.

➤ To encourage PE Teachers to develop a sense of responsibility in the field of Sports. To improve their own knowledge and also personal potential as a good Sports Promoter/Teacher/Trainer.

➤ To recognize the excellent, outstanding work done by the PE Teachers for moulding and bringing up the meritorious Sportspersons of Goa, who later excel and earn laurels at the State, National and International level.

➤ To encourage PE Teachers for effective implementation of the State Sports Policy of Goa.

➤ To promote sports culture and fitness for all concept.

➤ To implement PE syllabi very effectively for STD V to XII.

**Description of the Award**

➤ The award shall be given to the PE Teachers for their excellent work in different field of Sports & Physical Education activities.

➤ The number of awards given each year would not exceed two (2).

➤ The Awards shall be bestowed on 02 PE Teachers every year by scrutinizing their performance, achievements and merit. There will be 01 Teacher from Secondary School and 01 Teacher from Higher Secondary Schools to be selected and honored.

➤ The Award to PE Teachers will comprise of a Bronze Plaque embossed "State Award for Physical Education Teacher" with bust of Shri D. B. Bhandarkar, first Chief Minister of Goa and founder of erstwhile Directorate of Sports and Cultural Affairs in 1973. Besides the Plaque, it is proposed to award Rs 25,000/- to each of the awardee and a Shawl, coconut and a certificate.

#### **Conditions of eligibility for PE Teachers for Award**

(1) Ten (10) of years of regular service rendered by the PE Teacher is a must.

(2) Educational qualification of the Physical Education Teacher and other PE and Sports related courses, seminars attended/higher qualification acquired.

(3) Number of teams formed, trained and participated in the Inter HSS/Inter School Tournaments, out of which Athletics is compulsory. Participation in minimum 3 games or sports is a must.

(4) Performance of the school team at DSYA tournaments and open tournaments held by the recognized State Sports Associations (maximum medals in team sport championships and maximum medals in individual sports championship are a must).

(5) (a) Promotion of PE activities like Marching, Mass P. T., Mass Drill, Lazium, Lathi, Bhartiam, Yoga, Mass Displays etc. for Secondary schools P.E.T.

(b) Yoga and presentation of paper if any on PE/Sports for Higher Secondary PE Teachers.

(6) Contribution of the PE Teacher, in terms of extra PE and sports classes held, coaching/training imparted in the evening/morning/on holidays/in vacation etc.

(7) Attitude, approach, integrity and over all behavior of the PE Teacher.

(8) Control & command of PE Teacher on the students.

(9) Personal image of the PE Teacher in the Sports field due to the impact he/she has made.

#### **Submission of Proposal**

➤ Higher Secondary and Secondary Schools shall submit their recommendation to the Director of Sports & Youth Affairs, by the first week of June every year.

➤ In addition to the recommendations received from the concerned institutions, the Selection Committee at the State Level may at their discretion, consider on merit, a suitable candidate on their own.

➤ Proposal to be considered should be accompanied by 3 passport size photographs of the (PE T) candidate.

➤ Claims made by the applicant regarding conduct of tournaments or any other activities must be supported by certificates issued by the respective National Sports Federation, State Sports Association, etc.

#### **Selection of the Awards at State Level**

The State Level Co-ordination Committee, constituted as under shall scrutinize the applications and selection of candidates for the Awards:

➤ The tenure of the State Level Committee shall be for a period of 3 years, from the date of issue of necessary order by the Government.

➤ In case recommendations are not received by the State Level Committee by first week of July, from the institutions, then the State Level Selection Committee would proceed by making its recommendations after ascertaining the achievements of most meritorious PE Teacher based on their performance at school and HSS sports.

➤ The State Level Selection Committee shall scrutinize all the recommendations received from various institutions and recommend to the State Government at least 5 names of Physical Education Teachers, having shown excellence in promotion of Physical Education Sports and Games, in order of merit, for bestowing the State Award for Physical Education Teacher.

➤ The recommendations of the State Selection Committee, shall normally be accepted by the State Government. In case of any deviation, full justification for the same will have to be given by the committee.

#### **Presentation of Awards**

(1) Presentation of the Award shall be made at a special ceremony, organized by the Directorate of Sports and Youth Affairs to coincide with the closing ceremony of celebration of National Sports Day on 29th August each year.

(2) The awardees shall be invited to receive the award in person. TA/DA of the awardees for attending the Award Ceremony would be met by the Department of Sports and Youth Affairs.

#### **General Rules**

➤ Government of Goa, Directorate of Sports and Youth Affairs are competent to ascend this code at their discretion and taking into consideration the recommendations of State Level Co-ordination Committee, without any prior notice whatsoever.

➤ The necessary funds for the award and all expenses incidental thereon, as approved by the Government, shall be provided by the Government of Goa, Directorate of Sports and Youth Affairs.

➤ In case of any dispute, the decision of the Directorate of Sports & Youth Affairs will be final and binding on all concerned.

#### **Notification**

D.Tpt/Accts-KTCL-Subsidy/18/15-16/2275

The Government of Goa is pleased to frame the “Scheme for release of subsidies to Kadamba Transport Corporation Ltd. towards social cost.”

*Preamble.*— Government of Goa has established State Road Transport Undertaking in October, 1980. The aim and object of the STU was to provide safe and reliable bus transport service to villagers and remote area people and students, thus to connect villages in the State to the cities and to villages where private bus operators were not ready to accept to provide bus services, being uneconomical and to stop the unfair practices and poor quality of services provided by private operators. The service was extended with concessions to senior citizens, physically disabled, blind, veteran ladies, cancer patients, freedom fighters, students, HIV Aids patients etc. as per directives of the Government. Kadamba Transport Corp. Ltd. operates around 200 to 250 kms per day buses on intra state routes to meet the demands of people in Goa.

For the above transport services, facilities to provide Kadamba Transport Corp. Ltd. has to sustain losses being not matching cost of operation with that amount of revenue earned.

The rate of passenger fare for transport services on which the major portion of income is dependable is decided and fixed by the Government and therefore the Corporation has no scope to increase the rate of fare as per increase in cost of inputs and has to continue with operation of uneconomical transport services.

1. *Short title and commencement.*— (i) The scheme shall be called “Scheme for release of subsidy to KTCL towards social cost”. (social obligatory services).

(ii) The scheme shall come into force from the date of its Notification in the Official Gazette.

2. *Objectives.*— The main objectives of the scheme are as follows:—

(i) Kadamba Transport Corp. Ltd. shall operate social obligatory services for the benefit of people connecting villages with towns and cities in the State to aid, assist, promote, expedite and accelerate the development of communication and transport facilities throughout the State of Goa and services to the public at large.

(ii) KTCL shall extend services with concessions to senior citizens, physically disabled, blind, veteran ladies, cancer patients, freedom fighters, students, HIV Aids patients etc. as per directives of the Government.

(iii) KTCL shall provide passenger amenities/ facilities at all the bus stands in the State of Goa and carry out the maintenance and upkeep of these bus stands.

(iv) KTCL shall make necessary arrangement to provide buses to various Government Departments and agencies as per the demand, against payment of prescribed charges.

(v) KTCL shall provide late night services, emergency services, support to the Disaster Management Cell in the State of Goa and any other services as per directions of the Government from time to time.

3. *Scope of the scheme.*— The smooth running of Kadamba Transport Corp. Ltd. is very much essential to provide transport services as per the need of the people with the facilities of concessions extended as per directives of Government and for operation of transport services on interstate routes in neighbouring states to facilitate the people for interstate movements.

4. *Eligibility conditions under the scheme.*— KTCL is providing social obligatory services, it requires financial assistance of Rs. 500 lakhs towards monthly expenditure for operation of transport services which it provides to the people of Goa with concessions to the various categories of people.

As the revenue which is earned as per the fare fixed by the Government is not enough to meet expenditures of operations it requires the above financial assistance.

5. *Procedure for claiming subsidy.*— (i) KTCL depending upon requirement of financial assistance from the State Government shall submit the proposal to the Transport Department for making provision in Annual Plan against subsidy amounting to Rs. 6500 lakhs.

(ii) Once the Annual Plan is passed by the Legislative Assembly and assented to by the Governor, depending upon the need of the Corporation, the Corporation shall move a proposal to the Transport Department for releasing the amount of Rs. 6500 lakhs provided in the Annual Plan in four quarterly installments spread out over the financial year towards salary.

(iii) The Transport Department shall seek administrative approval and refer the matter to the Finance Department for concurrence of the same and for releasing the amount to KTCL.

6. *Conditions for release of subsidy to KTCL.*—  
(i) KTCL shall operate social obligatory services for social benefits connecting villages with towns and cities in the State and shall operate buses on interstate routes in the neighbouring States.

(ii) KTCL shall assist, initiate, promote, expedite and accelerate the development of communication and transport facilities throughout the State of Goa at service to the public at large.

(iii) KTCL shall provide late night services, emergency services, support the disaster management cell in the State of Goa and any other services as per the directions of the Government from time to time.

(iv) KTCL shall extend concessional services to category passengers like senior citizens, freedom fighters, students, differently abled, blind, cancer, HIV patients etc. as per the directives and as notified by the Government from time to time.

(v) KTCL shall submit Utilisation Certificate in the prescribed form after utilization of the amount of subsidy and before the release of next amount of subsidy installment, whichever is earlier.

(vi) KTCL shall submit an Audited Statement of Accounts by a registered Chartered Accountant within a period of six months from the close of the Financial Year.

(vii) Non-submission of Utilisation Certification or Audited Statement of Accounts or violation of terms and conditions, stipulated therein would act as disqualification for getting subsidy from the Government.

(viii) KTCL and its records shall be opened to inspection by the Directorate of Transport or his nominee at any point of time.

7. *Relaxation.*— The Government shall be empowered to relax any or all clauses or conditions of the scheme in genuine cases for release of Financial Assistance to be recorded in writing.

8. *Interpretation.*— If any question arises regarding interpretation of any clauses, word or expression of the scheme, the decision shall lie with the Directorate of Transport which shall be final and binding on all concerned.

Whereas certain draft Amendment Rules further to amend the Goa, Daman and Diu Motor Vehicles Tax Rules, 1974, which the Government of Goa proposed to make in exercise of the powers conferred by sub-sections (1) and (2) of section 24 of the Goa, Daman and Diu Motor Vehicles Tax Act, 1974 (Act No. 8 of 1974) (hereinafter referred to as the "said Act") were published as required by sub-section (1) of section 24 of the said Act, in the Official Gazette, Series I No. 12 dated 18-6-2015, under Notification No. D.Tpt/EST/2305/2015/2020 dated 12-6-2015 of the Directorate of Transport, Panaji, inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of publication of the said Notification in the Official Gazette.

And whereas the said Gazette was made available to the public on 2-4-2015.

And whereas no objections and suggestions have been received from the public on the said draft by the Government.

Now therefore, in exercise of the powers conferred by sub-sections (1) and (2) of section 24 of the Goa, Daman and Diu Motor Vehicles Tax Act, 1974 (Act No. 8 of 1974), and all other

powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa, Daman and Diu Motor Vehicles Tax Rules, 1974, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Motor Vehicles Tax (Amendment) Rules, 2015.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. *Amendment of rule 14.*— In rule 14 of the Goa, Daman and Diu Motor Vehicles Tax Rules, 1974, for the words “fee of five rupees”, the words “fee of one hundred rupees” shall be substituted.
