Whereas draft rules further to amend the Goa Motor Vehicles Rules, 1991, were published as required by sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) (hereinafter referred to as the said Act), in the Official Gazette, Series I No. 18 dated 4-8-2016 vide Notification No. D.Tpt/EST/2427/2016/2589 dated 2-8-2016 inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of publication of the said Notification in the Official Gazette.

And whereas the said Gazette was made available to the public on 4-8-2016.

And whereas no any objections and suggestions have been received from the public on the said draft by the Government.

Now therefore, in exercise of the powers conferred by sections 26, 28, 38, 65, 95, 107, 111, 138, 159, 176 and 213 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Motor Vehicles Rules, 1991, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Motor Vehicles (Amendment) Rules, 2016.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. *Insertion of new rule 310A.*— In the Goa Motor Vehicles Rules, 1991, after rule 310, the following rule shall be inserted, namely:—

“310(A) *Facilitation fee.*— For inspection of the motor vehicles, as specified in the column (2) of the Table below, by the Registering Authority at the premises of the dealer, the facilitation fees as specified in the corresponding entries in column (3) of the said Table shall be levied.

TABLE

Sr. No.	Type of motor vehicle	Fees per motor vehicle
(i)	Motor cycle/Motor scooter	Rs. 200/-
(ii)	Auto rickshaw/Tricycle (non-transport)	Rs. 300/-
(iii)	Light Motor Vehicle/Tractor (non-transport)	Rs. 400/- .”.
