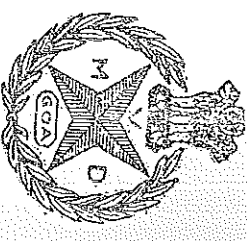

AUCTION NOTICE

Sealed Tender are invited to dispose off Unserviceable and condemned Qualis Jeep bearing No.GA-01/G-2444 on "**AS IS WHERE IS, WHAT IS & NO COMPLAINT BASIS**" so as to reach the office of the Directorate of Transport, Junta House, Panaji – Goa upto 10.30 a.m. on 11/10/2017 (1 lot).

Tenders will be opened in the office of the Directorate of Transport, Junta House, Panaji on same day at 11.00 a.m. during which period the tenderers or their authorized representatives may remain present. Tender catalogue alongwith terms and conditions can be obtained from the same office on all working days/hrs. on payment of Rs.500/- (non refundable) per set from 03/10/2017 to 10/10/2017 (upto 4.00 P.M.)

Lots shall be available for inspection from 03/10/2017 to 10/10/2017 (upto 4.00 P.M.) as per details of location mentioned in the tender in the catalogue.

(a) E.M.D will be at the rate of 25% of the quoted bid value per lot in case of disposal of vehicles and Heavy machinery/equipments etc. and disposal of furniture and other items. The same shall be in the form of D.D/Pay order/D.C.R of any scheduled Bank drawn in favour of Director of Transport, Directorate of Transport, Panaji – Goa payable at Panaji and to be enclosed by all bidders alongwith their offer.


(b) The balance 75% of highest bid value of each lot should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder.

This balance payment shall also be in the form of pay order/DD/DCR of any scheduled Bank drawn in favour of Director of Transport, Panaji payable at Panaji. In case of failure to make balance payment in time the amount deposited as per clause (b) above shall stand forfeited.

The successful bidder shall lift lot (s) within 3 weeks of receiving intimation letter/Delivery order from Department and failure to do the same, then the amount deposited as per clause (b) and (c) above shall stand forfeited.

VAT shall be payable on disposal of all condemned articles.

The Department reserves the right to accept or reject any or all tenders without assigning any reasons thereof.
